

PhillipMart Announces Pre-IPO Share Price of SG Group Holdings Limited (Stock code: 08442)

(Hong Kong – 20 March 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **SG Group Holdings Limited** (SG Group Hldgs, stock code: 08442) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SG Group Hldgs on PhillipMart were HK\$7.58 and HK\$6.20. The price closed at HK\$6.30 per share,9.57% higher than its offer price of HK\$\$5.75. The price opened at HK\$6.50, with the most actively traded price of HK\$7.48 per share, and a turnover of 55,000shares. The total trading volume reached 576,500 shares with **total turnover of HK\$3,916,030.00.** The final price of SG Group Hldgs, to debut trading tomorrow has been fixed at HK\$5.75per share.
