

## PhillipMart Announces Pre-IPO Share Price of Minsheng Education Group Company Limited (Stock code: 01569)

(Hong Kong – 21March 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Minsheng Education Group Company Limited** (stock code: 01569) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Minsheng Education** on PhillipMart were HK\$1.58 and HK\$1.47. The price closed at HK\$1.5 per share,8.7% higher than its offer price of HK\$\$1.38. The price opened at HK\$1.47, with the most actively traded price of HK\$1.5 per share, and a turnover of 2,684,000shares.
