

## PhillipMart Announces Pre-IPO Share Price of SHIS Limited (Stock code: 01647)

(Hong Kong – 29 March 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **SHIS Limited** (stock code: 01647) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **SHIS Limited** on PhillipMart were HK\$0.73 and HK\$0.54. The price closed at HK\$0.58 per share, 17.14% lower than its offer price of HK\$\$0.7. The price opened at HK\$0.73, with the most actively traded price of HK\$0.59 per share, and a turnover of 2,095,000shares. The total trading volume reached 5,970,000shares with **total turnover of HK\$3,541,900.00.** The final price of **SHIS Limited**, to debut trading tomorrow has been fixed at HK\$0.7 per share.
