

**PhillipMart Announces Pre-IPO Share Price of  
 Chanhigh Holdings Limited (Stock code: 02017)**

(Hong Kong – 30 March 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Chanhigh Holdings Limited (Chanhigh ; stock code: 02017)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chanhigh** on PhillipMart were HK\$2.38 and HK\$2.25. The price closed at HK\$2.30 per share, 5.99% higher than its offer price of HK\$2.17. The price opened at HK\$2.31, with the most actively traded price of HK\$2.30 per share, and a turnover of 2,840,000 shares. The total trading volume reached 7,118,000 shares with **total turnover of HK\$16,387,800.00**. The final price of **Chanhigh**, to debut trading tomorrow has been fixed at HK\$2.17 per share.
