PhillipMart Announces Pre-IPO Share Price of Milestone Builder Holdings Limited (Stock code: 01667)

(Hong Kong – 6 April 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Milestone Builder Holdings Limited** (Milestone Builder; stock code: 01667) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Milestone Builder on PhillipMart were HK\$0.7 and HK\$0.56. The price closed at HK\$0.63 per share,21.15% higher than its offer price of HK\$\$0.52. The price opened at HK\$0.65, with the most actively traded price of HK\$0.62 per share, and a turnover of 7,260,000shares. The total trading volume reached 20,640,000shares with **total turnover of HK\$12,748,400.00**. The final price of Milestone Builder, to debut trading tomorrow has been fixed at HK\$0.52 per share.
