

**PhillipMart Announces Pre-IPO Share Price of
 BCI Group Holdings Limited (Stock code: 8412)**

(Hong Kong – 6 April 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of BCI Group Holdings Limited (“BCI Group Holdings Limited”; stock code: 8412) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for BCI Group Holdings Limited on PhillipMart were HK\$0.37 and HK\$0.34. The price closed at HK\$0.37 per share, 8.82% higher than its offer price of HK\$0.34. The price opened at HK\$0.355, with the most actively traded price of HK\$0.36 per share, and a turnover of 4,190,000 shares. The total trading volume reached 8,910,000 shares with **total turnover of HK\$3,199,450.00**. The final price of **BCI Group Holdings Limited**, to debut trading tomorrow has been fixed at HK\$0.34 per share.
