

## PhillipMart Announces Pre-IPO Share Price of Guotai Junan Securities Co., Limited (Stock code: 02611)

(Hong Kong – 10 April, 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Guotai Junan Securities Co., Limited (GTJA;** stock code: 02611) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **GTJA**, Inc. on PhillipMart were HK\$16.10 and HK\$15.98. The price closed at HK\$16.00 per share1.01% higher than its offer price of HK\$\$15.84. The price opened at HK\$16.10, with the most actively traded price of HK\$16.00 per share, and a turnover of 1,917,600 shares. The total trading volume reached 2,966,000 shares with **total turnover of HK\$47,482,576.00**. The final price of **GTJA**, to debut trading tomorrow has been fixed at HK\$15.84 per share.
