PhillipMart Announces Pre-IPO Share Price of F8 Enterprises (Holdings) Group Limited (Stock code: 08347)

(Hong Kong – 11 April 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **F8 Enterprises (Holdings) Group Limited (F8 ENT; stock code: 08347)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **F8 ENT** on PhillipMart were HK\$0.365 and HK\$0.33. The price closed at HK\$0.36 per share, 12.5% higher than its offer price of HK\$\$0.32. The price opened at HK\$0.33, with the most actively traded price of HK\$0.34 per share, and a turnover of 1,680,000shares. The total trading volume reached 7,560,000shares with **total turnover of HK\$2,622,040.00**. The final price of **F8 ENT**, to debut trading tomorrow has been fixed at HK\$0.32per share.
