

## PhillipMart Announces Pre-IPO Share Price of Lai Group Holding Company Limited (Stock code: 8455)

(Hong Kong – 11 April 2017 ) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Lai Group Holding Company Limited ("Lai Group"; stock code: 8455) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Lai Group on PhillipMart were HK\$0.265 and HK\$0.255. The price closed at HK\$0.26 per share, the same as its offer price of HK\$0.26. The price opened at HK\$0.255, with the most actively traded price of HK\$0.265 per share, and a turnover of 230,000 shares. The total trading volume reached 290,000 shares with **total turnover of HK\$76,500.00**. The final price of **Lai Group**, to debut trading tomorrow has been fixed at HK\$0.26 per share.
