

PhillipMart Announces Pre-IPO Share Price of Man Shing Global Holdings Limited (Stock code: 08309)

(Hong Kong – 12 April 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Man Shing Global Holdings Limited** (Man Shing Global; stock code: 08309) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Man Shing Global on PhillipMart were HK\$0.4 and HK\$0.33. The price closed at HK\$0.365 per share,14.06% higher than its offer price of HK\$\$0.32. The price opened at HK\$0.33, with the most actively traded price of HK\$0.36 per share, and a turnover of 2,980,000shares. The total trading volume reached 15,350,000 shares with **total turnover of HK\$5,538,250.00**. The final price of Man Shing Global, to debut trading tomorrow has been fixed at HK\$0.32 per share.
