

**PhillipMart Announces Pre-IPO Share Price of  
 Windmill Group Limited (Stock code: 08409)**

(Hong Kong – 13 April 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Windmill Group Limited** (Windmill Group ; stock code: 08409) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Windmill Group** on PhillipMart were HK\$0.34 and HK\$0.305. The price closed at HK\$0.32 per share 18.52% higher than its offer price of HK\$0.27. The price opened at HK\$0.34, with the most actively traded price of HK\$0.31 per share, and a turnover of 880,000 shares. The total trading volume reached 1,990,000 shares with **total turnover of HK\$622,300.00**. The final price of **Windmill Group**, to debut trading tomorrow has been fixed at HK\$0.32 per share.
