

**PhillipMart Announces Pre-IPO Share Price of  
 China New Higher Education Group Limited (Stock code: 02001)**

(Hong Kong – 18 April 2017 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of China New Higher Education Group Limited (“China New Higher Edu”; stock code: 02001) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China New Higher Edu on PhillipMart were HK\$2.8 and HK\$2.78. The price closed at HK\$2.78 per share, same as its offer price of HK\$2.78. The price opened at HK\$2.78, with the most actively traded price of HK\$2.78 per share, and a turnover of 163,000 shares. The total trading volume reached 316,000 shares with **total turnover of \$881,410.00**. The final price of China New Higher Edu, to debut trading tomorrow has been fixed at HK\$2.78 per share.
