

**PhillipMart Announces Pre-IPO Share Price of  
 EDVANCE INTERNATIONAL HOLDINGS LIMITED (Stock code: 08410)**

(Hong Kong – 18 April 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **EDVANCE INTERNATIONAL HOLDINGS LIMITED (EDVANCE INTL ; stock code: 08410)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **EDVANCE INTL** on PhillipMart were HK\$0.335 and HK\$0.325. The price closed at HK\$0.33 per share, 3.13% higher than its offer price of HK\$0.32. The price opened at HK\$0.335, with the most actively traded price of HK\$0.33 per share, and a turnover of 5,920,000 shares. The total trading volume reached 7,660,000 shares with **total turnover of HK\$2,531,800**. The final price of **EDVANCE INTL**, to debut trading tomorrow has been fixed at HK\$0.32 per share.
