

**PhillipMart Announces Pre-IPO Share Price of  
 BOCOM INTERNATIONAL HOLDINGS COMPANY LIMITED (Stock code: 03329)**

(Hong Kong – 18 May 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of BOCOM INTERNATIONAL HOLDINGS COMPANY LIMITED (Bocom Intl; stock code: 03329) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bocom Intl on PhillipMart were HK\$2.73 and HK\$2.68. The price closed at HK\$2.73 per share, 1.87 % higher than its offer price of HK\$2.68. The price opened at HK\$2.69, with the most actively traded price of HK\$2.71 per share, and a turnover of 615,000shares. The total trading volume reached 1,176,000shares with **total turnover of HK\$3,192,390.00**. The final price of Bocom Intl, to debut trading tomorrow has been fixed at HK\$2.68 per share.
