

**PhillipMart Announces Pre-IPO Share Price of  
 FY FINANCIAL (SHENZHEN) CO., LTD. (Stock code: 08452)**

(Hong Kong – 22 May 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **FY FINANCIAL (SHENZHEN) CO., LTD. (FY FINANCIAL)**; stock code: 08452) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **FY FINANCIAL** on PhillipMart were HK\$1.35 and HK\$1.25. The price closed at HK\$1.35 per share, 3.05% higher than its offer price of HK\$1.31. The price opened at HK\$1.31, with the most actively traded price of HK\$1.35 per share, and a turnover of 400,000 shares. The total trading volume reached 862,000 shares with **total turnover of HK\$1,145,140.00**. The final price of **FY FINANCIAL**, to debut trading tomorrow has been fixed at HK\$1.31 per share.
