

PhillipMart Announces Pre-IPO Share Price of VBG International Holdings Limited (Stock code: 8365)

(Hong Kong – 25 May 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of VBG International Holdings Limited ("VBG International"; stock code: 08365) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for VBG International on PhillipMart were HK\$0.68 and HK\$0.61. The price closed at HK\$0.61 per share, 10.29% lower than its offer price of HK\$0.68. The price opened at HK\$0.68, with the most actively traded price of HK\$0.63 per share, and a turnover of 390,000 shares. The total trading volume reached 935,000shares with **total turnover of \$589,450.00**. The final price of VBG International, to debut trading tomorrow has been fixed at HK\$0.68 per share.
