

**PhillipMart Announces Pre-IPO Share Price of  
 Speed Apparel Holding Limited (Stock code: 08183)**

(Hong Kong – 29 May 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Speed Apparel Holding Limited (Speed Apparel)**; stock code: 08183) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Speed Apparel** on PhillipMart were HK\$0.55 and HK\$0.48. The price closed at HK\$0.53 per share, 6% higher than its offer price of HK\$0.5. The price opened at HK\$0.53, with the most actively traded price of HK\$0.53 per share, and a turnover of 1,180,000 shares. The total trading volume reached 5,055,000 shares with **total turnover of HK\$2,537,925.00**. The final price of **Speed Apparel**, to debut trading tomorrow has been fixed at HK\$0.5 per share.
