## PhillipMart Announces Pre-IPO Share Price of RISECOMM GROUP HOLDINGS LIMITED (Stock code: 01679)

(Hong Kong – 08 June 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **RISECOMM GROUP HOLDINGS LIMITED** (**RISECOMM GROUP**; stock code: 01679) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **RISECOMM GROUP** on PhillipMart were HK\$1.39 and HK\$1.2. The price closed at HK\$1.36 per share,36% higher than its offer price of HK\$\$1.
