

**PhillipMart Announces Pre-IPO Share Price of  
 RISECOMM GROUP HOLDINGS LIMITED (Stock code: 01679)**

(Hong Kong – 08 June 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **RISECOMM GROUP HOLDINGS LIMITED (RISECOMM GROUP)**; stock code: 01679) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **RISECOMM GROUP** on PhillipMart were HK\$1.39 and HK\$1.2. The price closed at HK\$1.36 per share, 36% higher than its offer price of HK\$1. The price opened at HK\$1.2, with the most actively traded price of HK\$1.3 per share, and a turnover of 1,032,500 shares. The total trading volume reached 5,047,500 shares with **total turnover of HK\$6,743,625.00**. The final price of **RISECOMM GROUP**, to debut trading tomorrow has been fixed at HK\$1.00 per share.
