

PhillipMart Announces Pre-IPO Share Price of WUXI BIOLOGICS (CAYMAN) INC. (Stock code: 02269)

(Hong Kong – 12 June 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **WUXI BIOLOGICS** (**CAYMAN**) **INC.** (**WUXI BIO**; stock code: 02269) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **WUXI BIO** on PhillipMart were HK\$22.9 and HK\$20.6. The price closed at HK\$22.85 per share,10.92% higher than its offer price of HK\$\$20.6. The price opened at HK\$21.8, with the most actively traded price of HK\$22.5 per share, and a turnover of 1,309,000shares. The total trading volume reached 7,873,500 shares with **total turnover of HK\$176,636,125.00**. The final price of **WUXI BIO**, to debut trading tomorrow has been fixed at HK\$20.6 per share.
