

**PhillipMart Announces Pre-IPO Share Price of  
 G & M Holdings Limited (Stock code: 06038)**

(Hong Kong – 12 Jun 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **G & M Holdings Limited** (“G & M Hldgs”; stock code: 06038) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **G & M Hldgs** on PhillipMart were HK\$0.53 and HK\$0.43. The price closed at HK\$0.53 per share, 29.27% higher than its offer price of 0.41. The price opened at HK\$0.46, with the most actively traded price of HK\$0.49 per share, and a turnover of 395,000 shares. The total trading volume reached 22,940,000 shares with **total turnover of \$11,228,350.00**. The final price of **G & M Hldgs**, to debut trading tomorrow has been fixed at 0.41 per share.
