

PhillipMart Announces Pre-IPO Share Price of In Technical Productions Holdings Limited (Stock code: 08446)

(Hong Kong – 13 June 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **In Technical Productions Holdings Limited** (**ITP Holding**; stock code: 08446) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **ITP Holding** on PhillipMart were HK\$0.42 and HK\$0.365. The price closed at HK\$0.3 per share,40% higher than its offer price of HK\$\$0.3. The price opened at HK\$0.37, with the most actively traded price of HK\$0.42 per share, and a turnover of 570,000shares. The total trading volume reached 1,600,000shares with **total turnover of HK\$643,550.00**. The final price of **ITP Holding**, to debut trading tomorrow has been fixed at HK\$0.3per share.
