

PhillipMart Announces Pre-IPO Share Price of Kin Shing Holdings Limited (Stock code: 01630)

(Hong Kong – 15 June 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Kin Shing Holdings Limited (Kin Shing Holdings**; stock code: 01630) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Kin Shing Holdings** on PhillipMart were HK\$0.7 and HK\$0.445. The price closed at HK\$0.61 per share,60.53% higher than its offer price of HK\$\$0.38. The price opened at HK\$0.445, with the most actively traded price of HK\$0.54 per share, and a turnover of 1,032,000 shares. The total trading volume reached 1,172,000 shares with **total turnover of HK\$2,917,950.00.** The final price of **Kin Shing Holdings**, to debut trading tomorrow has been fixed at HK\$0.38 per share.
