

## PhillipMart Announces Pre-IPO Share Price of Basetrophy Group Holdings Limited (Stock code: 08460)

(Hong Kong – 26 June 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Basetrophy Group Holdings Limited** (**Basetrophy Group**; stock code: 08460) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Basetrophy Group** on PhillipMart were HK\$0.25 and HK\$0.218. The price closed at HK\$0.22 per share,8.33% lower than its offer price of HK\$\$0.24. The price opened at HK\$0.25, with the most actively traded price of HK\$0.245 per share, and a turnover of 2,400,000shares. The total trading volume reached 11,090,000 shares with **total turnover of HK\$2,704,180.00.** The final price of **Basetrophy Group**, to debut trading tomorrow has been fixed at HK\$0.24 per share.
