

## PhillipMart Announces Pre-IPO Share Price of Xin Point Holdings Limited (Stock code: 01571)

(Hong Kong – 27 June 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Xin Point Holdings Limited (Xin Point;** stock code: 01571) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Xin Point** on PhillipMart were HK\$3.52 and HK\$3.39. The price closed at HK\$3.51 per share,2.63% higher than its offer price of HK\$\$3.42. The price opened at HK\$3.45, with the most actively traded price of HK\$3.5 per share, and a turnover of 1,470,000shares. The total trading volume reached 5,888,000shares with **total turnover of HK\$20,511,990.00**. The final price of **Xin Point**, to debut trading tomorrow has been fixed at HK\$3.42 per share.

In view of customers demand, Phillip Securities announce that the trading hours of PhillipMart has be changed from 4:30p.m. - 6:00p.m. to 4:15p.m.-6:30p.m. effective from Thursday, 29 March 2012.
