## **PhillipMart Announces Pre-IPO Share Price of** Sheng Ye Capital Limited (Stock code: 08469)

(Hong Kong – 5 July 2017) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Sheng Ye Capital Limited (Shengye Capital; stock code: 08469) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Shengye Capital** on PhillipMart were HK\$2.4 and HK\$2.08. The price closed at HK\$2.11 per share, 5.5% higher than its offer price of HK\$\$2.00. The price opened at HK\$2.4, with the most actively traded price of HK\$2.2 per share, and a turnover of 578,000shares. The total trading volume reached 1,418,000shares with total turnover of HK\$3,084,760.00. The final price of **Shengye Capital**, to debut trading tomorrow has been fixed at HK\$2.00 per share.
