

PhillipMart Announces Pre-IPO Share Price of XIANGXING INTERNATIONAL HOLDING LIMITED (Stock code: 08157)

(Hong Kong – 6 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **XIANGXING INTERNATIONAL HOLDING LIMITED** (**XIANGXING INT**; stock code: 08157) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **XIANGXING INT** on PhillipMart were HK\$0.27 and HK\$0.23. The price closed at HK\$0.27 per share,22.73% higher than its offer price of HK\$0.22. The price opened at HK\$0.24, with the most actively traded price of HK\$0.23 per share, and a turnover of 640,000shares. The total trading volume reached 2,640,000shares with **total turnover of HK\$641,780.00**. The final price of **XIANGXING INT**, to debut trading tomorrow has been fixed at HK\$0.22 per share.
