

## PhillipMart Announces Pre-IPO Share Price of CPM Group Limited (Stock code: 01932)

(Hong Kong – 7 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **CPM Group Limited (CPM Group**; stock code: 01932) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **CPM Group** on PhillipMart were HK\$1 and HK\$0.86. The price closed at HK\$0.87 per share, 1.16% higher than its offer price of HK\$\$0.86. The price opened at HK\$0.95, with the most actively traded price of HK\$0.87 per share, and a turnover of 1,188,000shares. The total trading volume reached 5,064,000 shares with **total turnover of HK\$4,595,240.00**. The final price of **CPM Group**, to debut trading tomorrow has been fixed at HK\$0.86 per share.
