PhillipMart Announces Pre-IPO Share Price of DongGuang Chemical Limited (Stock code: 01702)

(Hong Kong – 10 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **DongGuang Chemical Limited (DongGuang Chemical;** stock code: 01702) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **DongGuang Chemical** on PhillipMart were HK\$1.18 and HK\$1.06. The price closed at HK\$1.1 per share,3.77% higher than its offer price of HK\$\$1.06. The price opened at HK\$1.07, with the most actively traded price of HK\$1.1 per share, and a turnover of 424,000shares.
