

**PhillipMart Announces Pre-IPO Share Price of  
 Evergreen Products Group Limited (Stock code: 01962)**

(Hong Kong – 11 July 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Evergreen Products Group Limited**; (stock code: 01962) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Evergreen Products** on PhillipMart were HK\$1.71 and HK\$1.52. The price closed at HK\$1.55 per share, 6.06% lower than its offer price of HK\$1.65. The price opened at HK\$1.71, with the most actively traded price of HK\$1.57 per share, and a turnover of 430,000 shares. The total trading volume reached 1,814,000 shares with **total turnover of HK\$2,890,960.00**. The final price of **Evergreen Products**, to debut trading tomorrow has been fixed at HK\$1.65 per share.
