

PhillipMart Announces Pre-IPO Share Price of UTS Marketing Solutions Holdings Limited (Stock code: 06113)

(Hong Kong – 11 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **UTS Marketing Solutions Holdings Limited (UTS Marketing**; stock code: 06113) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **UTS Marketing** on PhillipMart were HK\$1.84 and HK\$1.5. The price closed at HK\$1.73 per share,25.36% higher than its offer price of HK\$\$1.38. The price opened at HK\$1.5, with the most actively traded price of HK\$1.8 per share, and a turnover of 362,000shares. The total trading volume reached 1,290,000shares with **total turnover of HK\$2,261,860.00**. The final price of **UTS Marketing**, to debut trading tomorrow has been fixed at HK\$1.38 per share.
