

PhillipMart Announces Pre-IPO Share Price of Hang Chi Holdings Limited (Stock code: 8405)

(Hong Kong – 11 Jul 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Hang Chi Holdings Limited (“Hang Chi Hldg”; stock code: 8405) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hang Chi Hldg on PhillipMart were HK\$0.79 and HK\$0.72. The price closed at HK\$0.76 per share, 5.56% higher than its offer price of HK\$0.72. The price opened at HK\$0.73, with the most actively traded price of HK\$0.76 per share, and a turnover of 468,000 shares. The total trading volume reached 2,336,000 shares with **total turnover of HK\$1,755,360.00**. The final price of **Hang Chi Hldg**, to debut trading tomorrow has been fixed at HK\$0.72 per share.
