

**PhillipMart Announces Pre-IPO Share Price of
 FIT Hon Teng Limited (Stock code: 06088)**

(Hong Kong – 12 July 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **FIT Hon Teng Limited (IT Hon Teng; stock code: 06088)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **FIT Hon Teng Limited** on PhillipMart were HK\$2.73 and HK\$2.68. The price closed at HK\$2.74 per share, 1.48% higher than its offer price of HK\$2.7. The price opened at HK\$2.74, with the most actively traded price of HK\$2.74 per share, and a turnover of 2,412,000 shares. The total trading volume reached 6,949,000 shares with **total turnover of HK\$18,987,950.00**. The final price of **IT Hon Teng**, to debut trading tomorrow has been fixed at HK\$2.7 per share.
