

PhillipMart Announces Pre-IPO Share Price of My Heart Bodibra Group Limited (Stock code: 08297)

(Hong Kong – 12 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **My Heart Bodibra Group Limited (Bodibra**;

stock code: 08297) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Bodibra** on PhillipMart were HK\$0.4 and HK\$0.38. The price closed at HK\$0.39 per share,2.5% lower than its offer price of HK\$\$0.4. The price opened at HK\$0.4, with the most actively traded price of HK\$0.39 per share, and a turnover of 200,000shares. The total trading volume reached 370,000shares with **total turnover of HK\$144,950.00**. The final price of **Bodibra**, to debut trading tomorrow has been fixed at HK\$0.4 per share.
