

## PhillipMart Announces Pre-IPO Share Price of TOMO Holdings Limited (Stock code: 8463)

(Hong Kong – 12July 2017 ) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of TOMO Holdings Limited ("TOMO Holdings";

stock code: 8463) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for TOMO Holdings on PhillipMart were HK\$0.75 and HK\$0.73. The price closed at HK\$0.75 per share, 2.74% higher than its offer price of HK\$0.73. The price opened at HK\$0.73, with the most actively traded price of HK\$0.74 per share, and a turnover of 1,020,000 shares. The total trading volume reached 1,380,000 shares with **total turnover of HK\$1,019,760.00**. The final price of **TOMO Holdings**, to debut trading tomorrow has been fixed at HK\$0.73 per share.

In view of customers demand, Phillip Securities announce that the trading hours of PhillipMart has be changed from 4:30p.m. - 6:00p.m. to 4:15p.m.-6:30p.m. effective from Thursday, 29 March 2012.
