## PhillipMart Announces Pre-IPO Share Price of ShengLong Splendecor International Limited (Stock code: 8481)

(Hong Kong – 14 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of ShengLong Splendecor International Limited ("ShengLong Holdings"; stock code: 8481) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ShengLong Holdings on PhillipMart were HK\$1 and HK\$0.68. The price closed at HK\$0.79 per share, 16.18% higher than its offer price of HK\$0.68. The price opened at HK\$1, with the most actively traded price of HK\$0.77 per share, and a turnover of 150,000 shares. The total trading volume reached 650,000 shares with **total turnover of 504,600**. The final price of ShengLong Holdings, to debut trading tomorrow has been fixed at HK\$0.68 per share.
