

## PhillipMart Announces Pre-IPO Share Price of Wan Cheng Metal Packaging Company Limited (Stock code: 8291)

(Hong Kong – 17 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wan Cheng Metal Packaging Company Limited ("Wan Cheng Metal"; stock code: 8291) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Wan Cheng Metal on PhillipMart were HK\$0.7 and HK\$0.65. The price closed at HK\$0.7 per share, the same as its offer price of HK\$0.65.
