

**PhillipMart Announces Pre-IPO Share Price of
 Wealthy Way Group Limited (Stock code: 03848)**

(Hong Kong – 20 July 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Wealthy Way Group Limited (Wealthy Way; stock code: 03848)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Wealthy Way** on PhillipMart were HK\$6.39 and HK\$6.1. The price closed at HK\$6.38 per share, 14.75% higher than its offer price of HK\$5.56. The price opened at HK\$6.3, with the most actively traded price of HK\$6.38 per share, and a turnover of 54,000 shares. The total trading volume reached 284,000 shares with **total turnover of HK\$1,787,850.00**. The final price of **Wealthy Way**, to debut trading on 21 July. It has been fixed at HK\$5.56 per share.
