

**PhillipMart Announces Pre-IPO Share Price of
 CHINA SINGYES NEW MATERIALS HOLDINGS LIMITED (Stock code: 08073)**

(Hong Kong – 20 July 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **CHINA SINGYES NEW MATERIALS HOLDINGS LIMITED (SINGYES NM; stock code: 08073)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **SINGYES NM** on PhillipMart were HK\$8.99 and HK\$8.40. The price closed at HK\$8.69 per share, 2.24% higher than its offer price of HK\$1. The price opened at HK\$1.31, with the most actively traded price of HK\$8.62 per share, and a turnover of 1,267,500 shares. The total trading volume reached 6,189,000 shares with **total turnover of HK\$53,360,670.00**. The final price of **SINGYES NM**, to debut trading on 21 July. It has been fixed at HK\$1 per share.
