

PhillipMart Announces Pre-IPO Share Price of M&L HOLDINGS GROUP LIMITED (Stock code: 8152)

(Hong Kong – 20 July 2017) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of M&L HOLDINGS GROUP LIMITED ("M&L Holdings"; stock code: 8152) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for M&L Holdings on PhillipMart were HK\$0.7 and HK\$0.6. The price closed at HK\$0.7 per share, 48.94% higher than its offer price of HK\$0.47. The price opened at HK\$0.6, with the most actively traded price of HK\$0.7 per share, and a turnover of 290,000 shares. The total trading volume reached 810,000 shares with **total turnover of \$541,000**.00. The final price of M&L Holdings, to debut trading tomorrow has been fixed at HK\$0.47 per share.
