

PhillipMart Announces Pre-IPO Share Price of Tak Lee Machinery Holdings Limited (Stock code: 08142)

(Hong Kong – 26 July 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Tak Lee Machinery Holdings Limited (Tak Lee Machinery**; stock code: 08142) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Tak Lee Machinery** on PhillipMart were HK\$0.58 and HK\$0.36. The price closed at HK\$0.425 per share,3.41% lower than its offer price of HK\$0.44. The price opened at HK\$0.51, with the most actively traded price of HK\$0.44 per share, and a turnover of 7,530,000shares. The total trading volume reached 41,700,000shares with **total turnover of HK\$17,659,250.00**. The final price of **Tak Lee Machinery**, to debut trading on 27 July. It has been fixed at HK\$0.44 per share.
