

PhillipMart Announces Pre-IPO Share Price of Sisram Medical Ltd. (Stock code: 01696)

(Hong Kong – 18 Sep 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Sisram Medical Ltd.** (**Sisram Medical**; stock code: 01696) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sisram Medical** on PhillipMart were HK\$9.1 and HK\$8.74. The price closed at HK\$8.77 per share,1.24% lower than its offer price of HK\$\$8.88. The price opened at HK\$9, with the most actively traded price of HK\$8.88 per share, and a turnover of 330,000shares. The total trading volume reached 1,440,800shares with **total turnover of HK\$12,760,664.00.** The final price of **Sisram Medical**, to debut trading on 19 Sep. It has been fixed at HK\$8.88 per share.
