

**PhillipMart Announces Pre-IPO Share Price of
 Cool Link (Holdings) Limited (Stock code: 08491)**

(Hong Kong – 21 Sep 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Cool Link (Holdings) Limited (Cool Link;** stock code: 08491) on PhillipMart, an automated electronic platform for pre-IPO shares trading.
