

**PhillipMart Announces Pre-IPO Share Price of

(Hong Kong – 21 Sep 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Cool Link (Holdings) Limited (Cool Link; stock code: 08491)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Cool Link** on PhillipMart were HK\$0.62 and HK\$0.52. The price closed at HK\$0.55 per share its same as the offer price of HK\$0.55. The price opened at HK\$0.59, with the most actively traded price of HK\$0.55 per share, and a turnover of 695,000shares.
