

**PhillipMart Announces Pre-IPO Share Price of  
 ZhongAn Online P&C Insurance Co., Ltd (Stock code: 06060)**

(Hong Kong – 27 Sep 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **ZhongAn Online P&C Insurance Co., Ltd (ZA Online;** stock code: 06060) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **ZA Online** on PhillipMart were HK\$70.2 and HK\$66. The price closed at HK\$68.6 per share, 14.91% higher than its offer price of HK\$59.7. The price opened at HK\$66, with the most actively traded price of HK\$68 per share, and a turnover of 438,500 shares. The total trading volume reached 3,217,400 shares with **total turnover of HK\$219,629,545.00.** The final price of **ZA Online,** to debut trading on 28 Sep. It has been fixed at HK\$59.7 per share.
