

## PhillipMart Announces Pre-IPO Share Price of Noble Engineering Group Holdings Limited (Stock code: 08445)

(Hong Kong – 28 Sep 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Noble Engineering Group Holdings Limited** 

(**Noble Engineering Group**; stock code: 08445) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Noble Engineering Group** on PhillipMart were HK\$0.69 and HK\$0.58. The price closed at HK\$0.66 per share,40.43% higher than its offer price of HK\$0.47.
