

**PhillipMart Announces Pre-IPO Share Price of
 Geotech Holdings Limited (Stock code: 01707)**

(Hong Kong – 11 Oct 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Geotech Holdings Limited** (Geotech Holdings; stock code: 01707) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Geotech Holdings on PhillipMart were HK\$0.5 and HK\$0.385. The price closed at HK\$0.425 per share, 1.19% higher than its offer price of HK\$0.42. The price opened at HK\$0.46, with the most actively traded price of HK\$0.43 per share, and a turnover of 3,048,000 shares. The total trading volume reached 14,072,000 shares with **total turnover of HK\$5,874,880.00**. The final price of Geotech Holdings, to debut trading on 12 Oct. It has been fixed at HK\$0.42 per share.
