

**PhillipMart Announces Pre-IPO Share Price of
 Satu Holdings Limited (Stock code: 8392)**

(Hong Kong – 13 Oct 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Satu Holdings Limited (“Satu Holdings”; stock code: 8392) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Satu Holdings on PhillipMart were HK\$0.275 and HK\$0.24. The price closed at HK\$0.27 per share, 22.73% higher than its offer price of 0.22. The price opened at HK\$0.25, with the most actively traded price of HK\$0.246 per share, and a turnover of 2,930,000 shares. The total trading volume reached 18,780,000 shares with **total turnover of HK\$4,643,480**. The final price of Satu Holdings, to debut trading on 16 Oct. It has been fixed at 0.22 per share.
