

PhillipMart Announces Pre-IPO Share Price of Goal Rise Logistics (China) Holdings Limited (Stock code: 08457)

(Hong Kong – 17 Oct 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Goal Rise Logistics (China) Holdings Limited ("Goal Rise"; stock code: 08457) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Goal Rise on PhillipMart were HK\$0.385 and HK\$0.35. The price closed at HK\$0.365 per share, 21.67% higher than its offer price of HK\$0.3. The price opened at HK\$0.35, with the most actively traded price of HK\$0.36 per share, and a turnover of 3,370,000 股 shares. The total trading volume reached 15,760,000shares with **total turnover of HK\$5,772,200.00**. The final price of Goal Rise, to debut trading tomorrow has been fixed at HK\$0.3 per share.
