

**PhillipMart Announces Pre-IPO Share Price of
 Wing Chi Holdings Limited (Stock code: 06080)**

(Hong Kong – 19 Oct 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Wing Chi Holdings Limited** (Wing Chi Holdings; stock code: 06080) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Wing Chi Holdings** on PhillipMart were HK\$0.56 and HK\$0.51. The price closed at HK\$0.54 per share, 3.85% higher than its offer price of HK\$0.52. The price opened at HK\$0.55, with the most actively traded price of HK\$0.53 per share, and a turnover of 3,444,000 shares. The total trading volume reached 12,414,000 shares with **total turnover of HK\$6,602,160.00**. The final price of **Wing Chi Holdings**, to debut trading on 20 Oct. It has been fixed at HK\$0.52 per share.
